

TENDER FOR SUPPLYING NATURAL GAS FROM THE PRODUCTION OF NAFTA IN Q3 2022



INTRODUCTION

NAFTA a.s., a company authorized to operate in the energy sector in gas production, produces natural gas within the Slovak Republic in accordance with Act 251/2012 Coll. on energy, amending certain laws (Energy Act). This invitation to tender (hereinafter "ITT"), announces specifications for the supply of natural gas from own production of NAFTA a.s. in 2021. The supplied gas is eligible for SOS purposes.

The total purchase price is calculated by multiplying the unit purchase price and the natural gas supplied during the term of the Gas Supply Contract.

Fixed price in EUR/MWh to be used over the term of Gas Supply Contract and defined by the candidate in the application.

II. CONDITIONS FOR INVITATION

1. REGISTRATION

Internal rules require NAFTA to review its potential partners before it enters into a business relationship. For this reason, any candidate that wishes to participate in the submission of tenders for supplying natural gas is required to register. To register, first email your request to **gassale@nafta.sk**. NAFTA will then send a list of selected documents necessary for KYC (Know Your Customer). After completing this process, NAFTA will email candidates about whether they can participate in the tender and also what guarantees, if any, will be required from the candidate.

2. INVITATIONS TO TENDER AND SUBMISSIONS

Invitations and registration deadlines will be published on NAFTA's website. Candidates can email their bids to **gassale@nafta.sk.** The applicant should mention the requested gas volume and the tendered purchase price. The candidate may submit maximum one binding, irrevocable application by email.

3. EVALUATION OF TENDERS

NAFTA will evaluate the bids within 15 minutes after the deadline for submission and announce the results to the individ	ual
candidates.
